7. **Be aware that, where opting for Gift Aid, it is their legal responsibility to notify the Membership Secretary if they cease to be liable for UK income tax in the future.**

## PRIVACY POLICY

**Countesthorpe u3a** requires its members to provide their personal information in order that they can be kept informed about events and activities that are offered as part of their membership. At any time, a member may request to view or modify their data by contacting the Membership Secretary. In collecting, using, storing and processing members' personal information, **Countesthorpe u3a** will adhere to its "Data Protection Policy and Procedures" (*see the Archive section of website or available on request*). This policy has been updated and will be regularly reviewed to comply with the General Data Protection Regulation. **Countesthorpe u3a** will:

1. Store your data securely, and retain it only for as long as it is relevant and appropriate
2. Use your data to communicate with you as a **u3a** member about events, activities, membership and renewal of membership
3. Share your data with group leaders/convenors for those groups of which you are a member
4. Share your data, on a strictly limited basis, with those outside agencies directly relevant to your **u3a** activities and membership; eg: airlines/hotels/travel companies (regarding trips and visits) and with HMRC for accounting and gift aid
5. Use your data to communicate with you about specific issues that may have arisen during the course of your membership
6. Use your data to send you general information about the Third Age Trust (the national office to which all **u3as** are affiliated).
